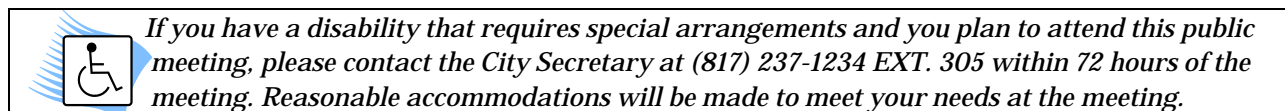

V. REGULAR AGENDA

ITEM 1. DISCUSSION/ACTION – Council will consider amending the 2013-2014 Budget at mid-year. Council may take any action deemed necessary.

ITEM 3. DISCUSSION/ACTION – Council will consider adopting Ordinance #371 an ordinance to control backflow and cross-connection devices in the Town of Lakeside Water distribution system. The Council may take any other action deemed necessary.
