III. <u>CONSENT AGENDA</u>—Approve minutes from January 8, 2015 Regular Council Meeting. Mayor Pro Tem Kim Ware made a motioned to approve the consent agenda. Council Member Dale Martin seconded the motion. Vote 3-0 motion carried.

IV. REGULAR AGENDA

<u>ITEM 6. DISCUSSION/ACTION</u> – Council will consider a Special Event Permit for John "Buc" Avanzini at 9518 Watercress Drive. Council may take any action deemed necessary. Mayor Pro Tem Kim Ware made a motion to approve the Special Event Permit for Mr. Avanzini. Council Member Bill Mohr seconded the motion. Vote 3-0 motion carrired.

<u>ITEM 5. DISCUSSION/ACTION</u> — Council will hear from Mr. Gary Nolan regarding his plans for adding to his property. Council may take any action deemed necessary. Mr. Nolan presented his request for permission to place a mobile home on his property to be used as living quarters for his employees taking care of his horses. There was a discussion as to what avenue the request should go through. Attorney Ken East stated he would pull the ordinance and review what action needs to be taken. No action was taken by the Council at this time.

ITEM 2. DISCUSSION/ACTION – Council will consider a Chapter 59 Forfeiture Agreement between the Town of Lakeside and the Office of Tarrant County Criminal District Attorney and authorize the Chief of Police to sign. Council may take any action deemed necessary. Mayor Pro Tem Kim Ware made a motion approve the agreement and to authorize the Chief of Police to sign the agreement. Council Member Bill Mohr seconded the motion. Vote 3 – 0 motion carried.

<u>ITEM 3. DISCUSSION/ACTION</u> – Council will consider retaining the McDonald Law firm in a class action lawsuit against Chesapeake. Council may take any action deemed necessary. Council Member Bill Mohr made a motion to retain the services of McDonald Law firm in a class action lawsuit against Chesapeake. Mayor Pro Tem Kim Ware seconded the motion. Vote 3 – 0 motion carried.

ITEM 4. DISCUSSION/ACTION – Council will consider Logo on the New Water Tank. Council may take any action deemed necessary. Mayor Pro Tem Kim Ware made a motion to put both the Town Logo and the name on the new water tower. Council Member Dale Martin seconded the motion. Vote 3 – 0 motion carried.

<u>ITEM 7. DISCUSSION/ACTION</u> - Council will discuss possible annexation of property in Ella Young. Council may take any action deemed necessary. Mayor Pro Tem Kim Ware made a motion to proceed with pursuing the voluntary annexation of property the Ella Young area. Council Member Bill Mohr seconded the motion. Vote 3-0 motion carried.

<u>ITEM 8. DISCUSSION/ACTION</u> – Council will consider approving an Interlocal Agreement between the Town of Lakeside and the City of Fort Worth for participation in Fort Worth's ECC Household Hazardous Waste Program for FY 2015. Council may take any action deemed necessary. Mayor Pro Tem Kim Ware made a motion to approve the agreement between the Town of Lakeside and the City of Fort Worth. Council Member Dale Martin seconded the motion. Vote 3-0 motion carried.

<u>ITEM 1. DISCUSSION/ACTION</u> – Council will discuss Private Water Wells. Council may take any action deemed necessary. After some discussion, Mayor Pro Tem Kim Ware made the following motion, to direct the Town Administrator to begin using the permit application in conjunction with sending letters with our existing Water Well Ordinance, with the modifications that you remove the word "repair" and change 30 days to 60 days. Further instruct the Town Administrator to direct the inspectors to follow up on the inspections of the existing wells and further study the necessary amendments to the existing Well Ordinance. And direct Randy to send letters to existing well owners, if necessary, to gather information necessary to proceed. Council Member Bill Mohr seconded the motion. Vote 3-0 motion carried.

<u>ITEM 9. DISCUSSION/ACTION</u> – Council will consider authorizing a Town Credit Card be issued to Norm. Council may take any action deemed necessary. After a discussion, the Mayor Pro Tem Kim Ware made a motion to authorize Norm Craven and Craig Bennett a Town credit card. Council Member Bill Mohr seconded the motion. Vote 3 – 0 motion carried.
