Council may take any action deemed necessary. Mr. Kevin Strasser, from Chesapeake Energy made his presentation to the Council on the Derek Weaver Pad Site Well Permit. Mayor Jacob requested that Chesapeake follow up on their offer to conduct educational sessions for the citizens. Mr. Strasser responded that he would set up some open houses for the residents. Council Member Dale Martin made a motion to approve the application request from Chesapeake Energy to drill and operate a gas well in the Town of Lakeside city limits. Mayor Pro Tem Kim Ware second the motion. Vote 4—1 motion carried.
