The Planning & Zoning Commission and City Council approved a Specific Use Permit for a mulch, compost and soil retail outlet (www.livingearth.net) to be constructed off Jacksboro Hwy. The Grand opening will be later this year.

Council approved Ordinance 393 ordering a special election to be held in the Town of Lakeside, Texas, on May 6, 2017, to re-authorize a sales and use tax in the Town of Lakeside, Texas, at the rate of one-fourth of one percent to provide revenue for the maintenance and repair of municipal streets.
