Water Meter Tampering

Just a reminder, unauthorized connection or disconnection of water in the Town of Lakeside is prohibited. The water meters are Town property and should not be touched by anyone unless authorized by the Town Administrator or Water Superintendent.

If you are having repairs done or have a leak and need your water off please call the Town Water Department at 817-237-1234 or after hours at 817-234-1224, you will press "0" when the recording comes on.

The fee for tampering is \$150.00 per violation and there are additional charges if anything is damaged.

WHEN DO I NEED A PERMIT?

The Town of Lakeside reminds residents of the importance of building codes and building permits. Most home improvement projects beyond cosmetic work require a building permit. The permit and inspection process helps protect your family from safety risks like structural failures, fire hazards or electrical shock. It may also help eliminate costly repairs for shoddy work. The following are some common projects that require permits:



- Installing or replacing water heaters, HVAC systems, water lines or sewer lines;
- Any electrical or gas line work;
- Installing solar panels;
- Building an addition;
- Pouring of concrete, widening/replacing driveway;

- Construction of a storage building, carports or patio cover;
- Installing a tornado shelter;
- Installing lawn irrigation systems;
- Installing storage sheds;
- Swimming pools and RV buildings
- ** Projects that are cosmetic, such as painting, wallpapering, carpeting, patching sheetrock, and trim work, etc., do not require permits.

Safety is the primary reason building permits are required. When a permit is issued, the City will inspect the work to make sure it is done correctly and in compliance with current building and safety codes. It is the homeowner's responsibility to make sure that their contractor obtains a building permit. You will be charged double the permit fee for any work done before a permit is obtained. Permits should be displayed on site until the work is completed and passes inspection. For more information, please contact Town Hall 817-237-1234 ext. 307.

Garage Sale Permits

With Spring upon us and Summer just around the corner, it is the perfect time for garage sales. If you plan on having one, please remember to first stop by Town Hall for a permit. Permits are \$10.00. Sales are limited to two per calendar year, and only on Friday, Saturday and Sunday.

House Watch

A House Watch is a request to the Police Department to make additional checks on your residence. This can be for a variety of reasons such as a vacation or business trip. If you are interested in a House Watch, go to the Town Hall website for the link for a House Watch Form or come by Town Hall to pick up. Your house will receive a little "extra attention" while you're away.



Unclog gutters

Drain flowerpot dishes

Apply mosquito dunks, bits and bri-

quettes to drains

Dump plastic wading pools

Turn wheelbarrows upside down

Dispose of unused tires or drill holes in them

Dump containers in yards

Fill tree holes with sand or cement Replace water in bird baths and ani-

mal dishes daily

Place mosquito eating fish in ponds

Check screens on windows and doors for tears

Keep vegetation trim to prevent adult resting

Check for leaky faucets and/or pipes

Apply repellents when heading outside. Mosquitoes may bite at any time—day or night.

Wear repellents approved by the Environmental Protection Agency (EPA). They have been approved after being tested for negative effects.

Active ingredients for repellents may include DEET, picaridin, IR3535 or oil of lemon-eucalyptus.

Read the label before applying any repellent.

Permethrin may be applied to clothing, bed nets or other supplies. Do not apply directly on skin.

Be wary of household products that "work" as repellents. Many do not protect you.
