CALL BEFORE YOU DIG!!!

As we look forward to Spring and nicer weather we look forward to doing our outdoor projects that we need to do. When doing projects around your house, digging without knowing where underground utility lines are buried can be very risky. When underground lines are damaged, vital services and everyday conveniences can become disconnected, not only to your home but to entire neighborhoods and sometimes, whole subdivisions. Don't risk harming yourself, your family or your neighbors. When planning an excavation project, simply dial **811** at least **48** hours (two working days) before you plan to start your work. **811** will notify most underground utility providers who will send professional locators out to mark the approximate location of their utility lines. Then you can dig confidently knowing the utilities will not be disturbed. The call is simple, free AND **IT'S THE LAW!** Know what's below, call **811** before you dig!

Lakeside Police Warn IRS Phone Scams Are Heating Up!

Aggressive phone calls claiming to be from the Internal Revenue Service are rampant as tax day nears. Citizens have been calling the police department to report IRS agents have called using scare tactics to solicit money for unpaid taxes.

To protect yourself from impostors who call, claiming to be from the IRS:

- Don't provide any account or other personal information. Hang up the phone.
- Never wire money to a person or company you don't know. Once you wire money, you can't get it back.
- If you've already paid your taxes, call and report the incident to TIGTA at 800-366-4484.
- Forward emails from the IRS to phishing@irs.gov. Don't open any attachments or click on any links in those emails. File a complaint with the Federal Trade Commission at ftc.gov/complaint. Include IRS Scam in your complaint.
