HALLOWEEN SAFETY TIPS

Children should always go out trick or treating accompanied by a responsible adult. If you have a group of kids going, the parents should choose two or three of them to go along and keep an eye on things. Instruct your children not to eat any treats until they bring them home to be examined by you; this way you can check for any problem candy. Instruct you child to never go into the home of a stranger or get into their car. Explain why this is not a good idea and what to do if someone approaches them and tries to talk to them. Make sure your child carries a flashlight, glow stick or has reflective tape on their costume to make them more visible to cars. Look both ways before crossing the street. Use established crosswalks wherever possible. Wear well fitting masks, costumes, and shoes to avoid blocked vision, trips and falls. Vandalism is never a good idea. Throwing eggs at cars and houses is a crime. Think about how you would feel if someone did that to your house and how bad it would make you feel.

The United Way of Tarrant County is sponsoring VITA which is an IRS-supported, free income tax preparation program for qualifying families throughout Tarrant County. With a coupon valued at \$300 you will be able to get your income tax return prepared and filed by an IRS-Certified Tax Preparer for FREE if your combined household income is \$50,000 or less. You don't have to have a coupon, but coupons will be available at Town Hall.

Bring the following Information with you: Tax Information such as W-2, 1099 or 1098, Social Security Card or TIN letter for you and all persons on your tax return, Proof of identity (Picture ID). When available a list of centers will be posted at the Town Hall Bulletin Board.
