## COUNCIL APPROVES FY 2013-2014 BUDGET

The Fiscal Year 2013-2014 operating budget was approved at the September 26 2013, Special Meeting. The budget is balanced and does not cut any essential services. The tax rate of \$0.379248 per \$100 of value was adopted which is the same rate as last year. Depending on the appraised value of your property, your tax may increase or decrease. Billing where more than one user is tied to the same meter. For 3/4 inch meters it is the base rate times X where X is the number of users plus volume charges. For meters larger than a 3/4 meter, it is the 3/4 base rate times X where X is the number of users plus volume charges or the actual meter size base rate plus volume charges whichever is greater.

### MESSAGE FROM THE MAYOR

Folks, we have a problem all of us are faced with as a community. It is not life threatening and we can fix it. The problem is our water system, as it stands today it has reached a point that it cannot support our town much longer. It's going to require extensive upgrades to provide for our future and continue to meet state mandated requirements. In order to do this we are going to have to finance the improvements and increase our rates to cover the cost. For the past several years the Town has been marginal in being able to keep up with water supply. To maintain the current level of service, the Water Department has worked very hard to maintain our water systems. This includes well and supply lines that bring water to our homes. In 2005, a drought year, we experienced a very sever water shortage. This was due to lack of a maintenance program for both the wells and the distribution systems. Since 2008 an extensive maintenance program has been implemented which has corrected most of the problems. However there are some problems maintenance alone cannot fix.

**(1) Supply:** Lakeside gets all of its water from water well. In 2011, again a drought year, even with restrictions, Lakeside could not keep up with demand with all our wells working 24/7. We survived only with additional emergency water purchases. **(2) Storage:** Again our town has marginal capacity to meet demands. In accordance with TCEQ, we are very close to falling below the recommend service levels for a state approved water supply system. **(3) Increasing Demand:** More people are moving to the DFW region. In Tarrant County the most logical area for expansion is toward our area. Recognizing water is a key issue and becoming a major issue in North Texas, the State of Texas has completed some of the most extensive studies ever done concerning ground water and regional demands on the aquifers. Since 2000 we have been included in a state authorized ground water district. This district charges commercial users for water they draw from the aquifers. Our system

is considered a commercial user. The costs assessed by the ground water district have been increasing. Like Ft Worth and every municipal entity in the region, Town Council has been extensively studying the situation for the past months. The question; what is required to make our water system adequate now and for the future? If water levels in the aquifers are decreasing, drilling new wells would not be a sound advice or a good investment. What alternative sources are available to us? What are the costs of those alternatives, both short and long term? These studies have included analysis of rates we pay for water and sewer. The studies indentified that neither the water nor sewer utility were breaking even, they were being subsidies with reserves and the General Fund. Engineering studies were conducted to determine the best system within our resources. Once completed, rates had to be adjusted to reduce the subsidies as well as the addition of an Interest and Sinking component in water rates to fund the improvements. **The Town's website has the latest information on the studies, and rate impacts. **BULKY AND LARGE ITEM WASTE PICKUP**
