

COUNCIL APPROVES FY 2014-2015 BUDGET

The Fiscal Year 2014-2015 operating budget was approved at the September 25, 2014, Special Meeting. The budget is balanced and does not cut any essential services. The tax rate of \$0.37926 per \$100 of value was adopted which is the same rate as last year. Depending on the appraised value of your property, your tax may increase or decrease. The budget is available for review on the Town's website at www.lakesidetexas.us or at Town Hall.

The United Way of Tarrant County Financial Stability Initiative

The United Way of Tarrant County is promoting a program call VITA (Volunteer Income Tax Assistance).

VITA is an IRS-supported, <u>free</u> income tax preparation program for qualifying families throughout Tarrant County. VITA reaches thousands of individuals and families, saing them the cost of tax preparation and helping them claim all the tax credits for which they are eligible. In 2014, VITA volunteers prepared 5, 198 return, helping families receive million of dollars in Earned Income Tax Credit (EITC), and begin a path toward financial stability!

You will be able to get your Income Tax return prepared and filed by an IRS-certified tax preparer for free, if your combined household income is \$50,000 or less. A coupon valued at \$300 is available for you to take to one of the Free Tax Centers located in Tarrant County. You will need to bring the following information with you when you go: Tax information such as W-2, 1099, or 1098, Social Security Card or ITIN letter for you and all persons on your tax return, and Proof of identity (Picture ID).

VITA is also looking for Volunteers to help at each location. If you are interested in volunteering there are four kinds of positions needed at every site: Greeters, Intake Specialist, Tax Preparers and Interpreters. MESSAGE FROM THE MAYOR

Water Wells: There has been a recent flurry of water well drilling in Lakeside. The Town has a process concerning wells. This process and its requirements can be found under Chapter 150.01 Water Wells. At the last Town Council meeting, concerns were expressed by some residents that the provisions of the ordinance were not being followed by both the land owner and the contractor. *Effective immediately* all recent wells (2014) will need to be reviewed to make sure that they are compliant with Chapter 150.01. Chapter 150.01 will be posted on the Town's web site for your convenience and for that of your selected drilling contractor. Any new wells in process or those currently contracted must be compliant with Section 150.01 before proceeding further. Please contact Town Hall with Questions.

BULKY AND LARGE ITEM WASTE PICKUP "LAKESIDE RESIDENTS ONLY"

The bulky and large item pickup will be held beginning October 15th. You may put items at your curb no sooner than Saturday, October 11th. You must have your items at your curb no later than Tuesday, October 14th by dark. The Large item pickup usually takes 5 to 7 days to complete after IESI begins to collect items. Large item pickup is limited to what two men can pick up in a 5 minute period. Be sure to secure items to prevent trash from blowing out onto the road.
