#### RESOLUTION NO. 2020-005006

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LAKESIDE, TEXAS, CONTINUING AND AMENDING THE <u>SECOND</u> <u>AMENDED</u> DECLARATION OF LOCAL DISASTER DUE TO PUBLIC HEALTH EMERGENCY. DECLARED BY THE MAYOR OF THE TOWN OF LAKESIDE, TEXAS IN ACCORDANCE WITH SECTION 30.066(C) OF THE TOWN CODE OF ORDINANCES AND TEXAS GOVERNMENT CODE SECTION 418.108 DUE TO THE COVID-19 PANDEMIC.

WHEREAS, in December 2019 a novel the World Health Organization has declared the coronavirus, now designated COVID-19, as a global pandemic on March 11, 2020; and

WHEREAS, COVID-19 was first detected in Wuhan-City, Hubei Province, China in December 2019; and

<u>WHEREAS</u>, with symptoms including fever, cough, and shortness of breath and with outcomes rangingCOVID-19 can range from mild to severe illness and in some cases, cause further complications including death; and

**WHEREAS,** on January 30, 2020, the World Health Organization Director General declared the outbreak of COVID-19 as a Public Health Emergency of International Concern (PHEIC), advising countries to prepare for the containment, detection, isolation and case management, contact tracing and prevention of onward spread of the disease;

WHEREAS, on March 5, 2020, the World Health Organization Director General urged aggressive preparedness and activation of emergency plans to aggressively change the trajectory of this epidemic;

WHEREAS, on March 11, 2020, the World Health Organization declared COVID-19 a worldwide pandemic;

WHEREAS, the Centers for Disease Control and Prevention is closely monitoring the growing number of cases that have spread into the United States and the identification of "community spread" cases of the COVID-19 in the United States signals that transmission of the virus is occurring;

WHEREAS, COVID 19 mainly spreads between people who are in close contact with one another through respiratory droplets produced when an infected person coughs or sneezes; and

**WHEREAS**, the continued worldwide spread of COVID-19 presents an imminent threat of widespread illness, which requires emergency action; for the protection of the people of the Town of Lakeside; and

WHEREAS, County Judge Glen Whitley issued a Declaration of Disaster Due to Public Health Emergency for Tarrant County for COVID-19 on March 13, 2020;

WHEREAS, Governor Greg Abbott issued a State of Disaster for all Texas counties for COVID-19 on March 13, 2020;

WHEREAS, President Donald Trump declared a State of National Emergency for the United States of America on March 13, 2020;

**WHEREAS,** pursuant to the Texas Disaster Act of 1975, the mayor is designated as the emergency management director of the Town of Lakeside, and may exercise the powers granted to the governor on an appropriate local scale;

WHEREAS, a declaration\_of local disaster\_and public health \_emergency\_includes\_the ability\_to reduce the possibility of exposure to disease, control the risk, promote health, <u>and</u>\_compel persons to undergo additional \_health measures \_that prevent or control the spread of disease, <u>including</u>. <u>These</u> <u>measures include</u> isolation, surveillance, quarantine, or placement of persons under public health observation, including the provision of temporary housing or emergency shelters for persons misplaced or evacuated\_<u>and\_</u>. <u>A declaration allows the</u> request <u>of</u>\_assistance from the <u>governor</u> <u>ofGovernor for</u> state resources; <u>and</u>

WHEREAS, by this Declaration of Local Disaster and Public Healthactivates the Tarrant County Emergency, I declare all rules and regulations that may inhibit or prevent prompt response to this threat suspended for the duration of the incident; Management Plan; and

**WHEREAS,** pursuant to the authority granted to the Mayor under the Texas Disaster Act of 1975, I authorize the use of all available resources of state government and political subdivisions to assist in the Lakeside's response to this situation  $\frac{1}{2}$ .

WHEREAS, I, Patrick Jacob, the Mayor of the Town of Lakeside have \_determined that extraordinary and immediate measures must be taken to <u>respond\_quickly</u>, <u>prevent\_and\_alleviatemitigate</u> the <u>sufferingeffects</u> of <u>people exposed to and those infected withthis public health emergency and to facilitate</u> the <u>virus</u>, as well as those that could potentially be infected or impacted by COVID-19efficient, rapid, and cooperative response to the emergency; and

WHEREAS, I, Patrick Jacob, the Mayor of the Town of Lakeside have issued a Declaration of Local Disaster due to Public Health Emergency on March 17, 2020; and hereby issue this anthe Lakeside Town Council approved Resolution 2020-005 approving a first amendment of Declaration of Local Disaster due to Public Health Emergency on March 19, 2020, and on March 22, 2020 I, Patrick Jacob, the Mayor of the Town of Lakeside issued a second Amended Declaration of Local Disaster Due to Public Health Emergency to implement additional measures to ensure the protection of the general public in the Town of Lakeside.

#### NOW THEREFORE BE IT PROCLAIMED BY THE MAYOR OF THE TOWN OF LAKESIDE, TEXAS:

- 1. The <u>Lakeside</u> Town Council hereby finds that the recitals set forth above are true and correct and are incorporated into this resolution as if written herein.
- 2. That a state of disaster and public health emergency is hereby declared for the Town of Lakeside, pursuant to §418.108(a) of the Texas Government Code.
- That the statethis Second Amended Declaration of disaster and public health emergencyLocal Disaster due to Public Health Emergency shall continue for a period of not more than sixty days of the date hereof, expire at 11:59 pm on Sunday April 5, 2020 unless the same is continued or renewed by the Lakeside Town Council of the Town of Lakeside, Texas, pursuant to \$418.108(b) of the Texas Government Code.
  - 4. That this declaration<u>A Declaration</u> of a local state of disaster and public health emergency shall be given prompt and general publicity and shall be filed promptly with the City Secretary, pursuant to §418.108(c) of the Texas Government Code.
- 5.4. That the Town's Emergency Operationsactivates the Tarrant County Emergency Management Plan is activated and implemented, pursuant to §418.108(d) of the Texas Government Code.
- 6.5. That this declaration This Declaration authorizes the Town of Lakeside to commandeer or

use any private property, temporarily acquire, <u>as provided</u> by lease or other means, sites required for temporary housing units or emergency shelters for evacuees, subject to compensation requirements, pursuant to §418.020(c) of the Texas Government Code law.

7. That this declaration authorizes the Town to take any actions necessary to promote health and suppress disease, including quarantine, examining and regulating hospitals, regulating ingress and egress from the Town, and fining those who do not comply with the Town's rules, pursuant to §122.006 of the Health and Safety Code.

#### That this declaration

- 6. This Declaration hereby limits the size of gatherings to no more than 5010 people and mandates the cancellation of all such gatherings of more than 5010 people until further notice. For purposes herein, a gathering is any indoor or outdoor event that brings together or is likely to bring together more than 10 people at the same time in a single space where people are present and within 6 feet of one another, without regard to the purpose of the gathering.
- 8.7. This declaration\_Declaration does not prohibit gatherings of people in multiple, separate enclosed spaces (including separate cubicles) in a single building such as different floors of a multi-level office, residential building, or hotel, \_so long as 50 not more than10 people are not-present in any single space at the same time. This declaration\_Declaration\_also does not prohibit the use of enclosed spaces where more than 10 people may be present \_at different \_times during the day, so long \_as more than 5010 people are not present in the space at the same time. For any gathering covered by this subsection, the Mayor of the Town of Lakeside strongly encourages compliance with the attached recommendations. The uses in Sections 8, 9, and 10 are This Declaration does not considered " make a distinction between types of gatherings," but are limited, i.e. social, community or prohibited as provided in Sections 8, 9, and 10 recreational.
- 9.8. That this declaration herebyThis Declaration orders that a restaurantrestaurants with or without drive-in or drive--through services; drive-in restaurantrestaurants; drive-through restaurantrestaurants; or microbrewerymicrobreweries, micro-distillerydistilleries, or winerywineries may only provide take out, delivery, or drive-in or drive--through services as declared, if permitted by the mayorlaw.
  - 10. That this declaration hereby orders the closure of a bar, lounge, or tavern; commercial amusement; theater; gym; and private club.
  - 11. That this declaration hereby limits the occupancy of the following locations to 50% occupancy as set forth on the business' certificate(s) of occupancy or 125 individuals, whichever is less:
    - a. Event Centers;
    - b. Hotel Meeting Spaces, and Ballrooms;
    - c. Retail Stores;
    - d. Convenience Stores;
    - e. Plazas;
    - f. Places of Worship; and
    - g. Malls (the occupancy of a mall is limited as follows: (i) common areas in a mall to 50% occupancy as set forth in the business's certificate(s) of occupancy or 125 individuals, whichever is less, and (ii) individual Retail Stores within a mall to 50% occupancy as set forth in the business's certificate(s) of occupancy or 125,

#### whichever is less).

- 9. This 50% occupancy limit does not apply to areas not listed above, including office buildings, government buildings, critical infrastructure such as airport and transit facilities, residential buildings, This Declaration orders that individuals cannot occupy nor can individuals be permitted to occupy the following: bars, lounges, taverns, commercial amusement establishments, bingo halls, theaters, gyms, private clubs, hair and nail salons and barber shops, estheticians and related personal care businesses, spas, massage parlors, tattoo and piercing parlors, tanning salons, residential meeting spaces, event centers, hotel meeting spaces and ballrooms, outdoor plazas and markets, malls and retail stores that do not sell essential household goods.
- 10. This Declaration allows the following entities to continue doing business as long as they enforce social separation: grocery stores, manufacturing locationsstores selling essential household goods, convenience and package stores, pharmacies and drug stores, day care facilities, medical facilities, non-profit service providers, airports, homeless and emergency shelters, day cares, and medical office buildings, essential government buildings, airports and transit facilities, transportation systems, residential buildings and hotels, and manufacturing and distribution facilities.
- <u>11. That this declaration In all such locations, there must be sufficient space for all people to be</u> <u>6 feet apart at all times to control infection. Where possible, a tracking list of the</u> <u>individuals present, and their contact information shall be maintained.</u>
- 12. Notwithstanding the above restriction, this Declaration is not intended to apply to any business operations delivering essential services. Essential Services means services, by whomsoever rendered, and whether rendered to the government or to any other person, the interruption of which would endanger life, health or personal safety of the whole or part of the population.
- 13. If someone in a household has tested positive for COVID-19, the household is ordered to isolate at home. Members of the household cannot go to work, school, or any other community function until cleared by a medical professional.
- 14. This Declaration closes worship services for in-person services, provided that needed staff can attend to produce audio/video services for transmission.
- **12.15**. This Declaration hereby authorizes the use of all lawfully available enforcement tools.
  - 13. That this declaration sets forth strong recommendations, attached hereto, for the purpose of mitigating the spread of COVID-19.
  - 14. That this proclamation shall take effect at 12:01am, March 20, 2020.
- <u>16. This Declaration incorporates the attached table, Disaster Restrictions, as if set forth</u> <u>verbatim herein.</u>
- 17. This Declaration shall be filed promptly with the Town Secretary.

#### TOWN OF LAKESIDE RECOMMENDATIONS FOR MITIGATING THE SPREAD OF COVID-19

The Town of Lakeside strongly recommends the following:

- (1) Cancel all nonessential gatherings and meetings of less than 50 people.
- (2) Create smaller groups for essential meetings, and consider holding video/audio meetings instead.
- (3) For individuals at increased risk of severe illness, cancel gatherings of more than 10 people, and limit nonessential outings. "Individuals at increased risk of severe illness" includes but is not limited to individuals 60 years and older; with compromised immune systems; with medical conditions such as diabetes, heart disease or disorders, or chronic obstructive pulmonary disease (COPD) or other lung conditions.
- (4) For operators of public spaces, provide ways for patrons to maintain safe social distancing, for example, maintaining six feet of separation between individuals; have hand washing capabilities, hand sanitizers and tissues available; and frequently cleaning high touch surface areas like counter tops, hand rails, and door knobs.
- (5) For workplaces, promote telecommuting; ensure employees do not work while sick; do not require a doctor's note for employees who are sick; maximize flexibility in sick leave benefits; and minimize the number of employees working within arm's length of one another.
- (6) For grocery stores and pharmacies, increase the use and capability of drive-thru, curbside, or delivery services; limit or restrict the number of customers permitted in a store at one time; minimize the number of employees working within arm's length of one another; provide handwashing capabilities, hand sanitizers, and tissues; and frequently clean high-touch surface areas like countertops, doorknobs, and handrails.

(7) Determine ways to consider providing support services, including meals, to individuals at

# DECLARATION OF LOCAL DISASTER DUE TO PUBLIC HEALTH EMERGENCY\_ SECOND AMENDED TOWN OF LAKESIDE, TEXAS

WHEREAS, in December 2019, Coronavirus Disease (COVID-19), caused by severe acute respiratory syndrome the World Health Organization has declared the coronavirus-2 (SARS-CoV-2), now designated COVID-19, as a global pandemic on March 11, 2020; and

WHEREAS, COVID-19 was first detected in Wuhan-City, Hubei Province, China in December 2019; and

**WHEREAS,** symptoms of COVID-19 include fever, cough, and shortness of breath, and outcomes have ranged<u>can range</u> from mild to severe illness and in some cases death; and

WHEREAS, on January 30, 2020, the World Health Organization Director General declared the outbreak of COVID-19 as a Public Health Emergency of International Concern and advised countries to prepare for the containment, cause further complications including active surveillance, early detection, isolation and case management, contact tracing, and prevention of onward spread of the disease death; and

**WHEREAS**, <u>the</u>COVID-19 <u>virus mainly</u> spreads between people who are in close contact with one another through respiratory droplets produced when an infected person coughs or sneezes; and

WHEREAS, on March 11, 2020, the World Health Organization declared COVID-19 a the continued worldwide pandemic; and

WHEREAS, continuous-spread of the disease <u>COVID-19</u> presents an imminent threat of widespread illness-or loss of life resulting from a global pandemic and other public calamity resulting therefrom, which requires emergency action for the protection of the people of the Town of Lakeside; and

WHEREAS, Governor Greg Abbott declared a State of Disaster for all Texas counties for COVID-19 on March 13, 2020; and

WHEREAS, a declaration of local disaster and public health emergency includes the ability to reduce the possibility of exposure to disease, control the risk, promote health, and compel persons to undergo additional health measures that prevent or control the spread of disease. These measures include isolation, surveillance, quarantine, or placement of persons under public health observation, including the provision of temporary housing or emergency shelters for persons misplaced or evacuated. A declaration allows the request of assistance from the Governor for state resources; and
