

ORDINANCE NO. 434

AN ORDINANCE AMENDING TITLE VII: TRAFFIC CODE / CHAPTER 71 (F) (1) TRAFFIC SCHEDULES / SCHEDULE II; STOP AND YIELD SIGNS; ADDING THE PLACEMENT OF STOP SIGNS AT ALL THREE CORNERS OF THE INTERSECTION OF EMILY RD AND PAINT BRUSH RD REQUIRING OBEDIENCE TO SAME; PROVIDING A PENALTY; PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE.

WHEREAS, it is necessary for the safety and welfare of the traveling public to install stop signs to control the flow of traffic in certain areas of the Town of Lakeside;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF LAKESIDE, TARRANT COUNTY, TEXAS:

SECTION I.

- A. Stop signs conforming to state law shall be placed at all three corners of the intersection of Emily Road and Paint Brush Road governing movement from Emily Rd onto Paint Brush Road.
- B. An operator of a vehicle, motor vehicle, truck, moped, bicycle or any other mode of transportation of persons or property approaching Paint Brush Rd while driving on Emily Rd shall come to a complete stop at a clearly marked stop line at the intersection on the two roadways, or, if there is not a clearly marked stop line, then at a place nearest the intersection of the two streets specified above where the stop sign is posted. After stopping, such operator shall grant immediate use of movement to persons or vehicles of any kind or nature on Emily Rd in obedience to the stop sign and after stopping may proceed only when the intersection can be safely entered without interference or collision with vehicular or pedestrian traffic using Paint Brush Rd.
- C. An operator of a vehicle, motor vehicle, truck, moped, bicycle or any other mode of transportation of persons or property approaching Emily Rd while driving on Paint Brush Rd shall come to a complete stop at a clearly marked stop line at the intersection of the two roadways, or, if there is not a clearly marked stop line, then at a place nearest the intersection of the two streets specified above where the stop sign is posted. After stopping, such operator shall grant immediate use of movement to persons or vehicles of any kind or nature on Paint Brush Rd in obedience to the stop sign and after stopping may proceed only when the intersection can be safely entered without interference or collision with vehicular or pedestrian traffic using Emily Road.

SECTION II.

Any person violating any provision of this Ordinance shall be guilty of a misdemeanor and upon conviction thereof, shall be fined in an amount not to exceed \$500.00.

SECTION III.

This Ordinance shall be cumulative of all provisions of ordinances of the Town of Lakeside, Texas, except where the provisions of this Ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.


SECTION IV.

It is hereby declared to be the intention to the Town Council that the phrases, clauses, sentences, paragraphs, and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the Town Council without the incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.


SECTION V.

This Ordinance shall be published as required by law and shall then be in full force and effect after the date of its publication and it is so ordained.
